THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE THE STAFF EDUCATION ASSOCIATION RETIREES' VEBA TRUST FUND, (EMPLOYER IDENTIFICATION NO. 27-2528791, PLAN NO. 501) FOR THE PERIOD JANUARY 1, 2015 TO DECEMBER 31, 2015. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

BASIC FINANCIAL STATEMENT

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$32,462,743 AS OF DECEMBER 31, 2015 COMPARED TO \$34,398,426 AS OF JANUARY 1, 2015. DURING THE PLAN YEAR THE PLAN EXPERIENCED A DECREASE IN ITS NET ASSETS OF \$1,935,683. THIS DECREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR. DURING THE PLAN YEAR, THE PLAN HAD TOTAL INCOME OF \$-870,995. THIS INCOME INCLUDED EMPLOYER CONTRIBUTIONS OF \$54,946, EMPLOYEE CONTRIBUTIONS OF \$63,944 AND EARNINGS FROM INVESTMENTS OF \$-989,885. PLAN EXPENSES WERE \$1,064,688. THESE EXPENSES INCLUDED \$163,211 IN ADMINISTRATIVE EXPENSES AND \$901,477 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES.
